The undersigned does also hereby give permission for our (my) child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in **YUC "BROCK GILL"** events and activities sponsored by Jamestown United Methodist Church. Further, should it be necessary for my child to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs.
